WHEREAS, a former chair of the Tennessee Auctioneer Commission, Terri Walker has won a number of awards during her auctioneering career, including the prestigious International Auctioneers Championship and Grand Champion honors in the Tennessee Auctioneers Association; and

WHEREAS, throughout her exemplary tenure as president of the National Auctioneers Association, Mrs. Walker has distinguished herself as a public-spirited citizen of the highest order and as an exceptional asset to this State; and

WHEREAS, Terri Walker has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of the auction industry and her community; and


WHEREAS, Terri Walker epitomizes the spirit and commitment that are characteristic of a true Tennessean and is worthy of our approbation; now, therefore,
