WHEREAS, Mr. Sanders was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born on June 7, 1925, in Mason, Allen Sanders was the son of Jesse Allen Sanders and Lena Bailia Sanders; he graduated from Fayette County High School in 1943, thereafter serving his country valiantly in the U.S. Army Air Corps during World War II; and
