WHEREAS, AGB, the premier organization representing higher education governing boards, established the Nason Award in 1992; the award is presented to higher education governing boards that demonstrate exceptional leadership and initiative; and


WHEREAS, it is most fitting that this esteemed body be recognized at this time; now, therefore,
