WHEREAS, Eel Etc. Accessories opened in 1992 in the Benchmark Hotel; the name was later changed to the Memphis Gift Shop, and it existed for twenty years until the hotel's demolition; and

WHEREAS, a devout Christian, Mr. Clark has been a member of the Mount Vernon Baptist Church for more than fifty years; and

WHEREAS, he is most grateful for the love and support of his wife of sixteen years, Doris; his two children, Shantel Clark and the late Justin L. Clark; and his grandson, Jalen L. Clark; and

WHEREAS, throughout his estimable career, James Clark has demonstrated the utmost professionalism, ability, and integrity; his commitment to excellence and community service is representative of the Volunteer State, and he should be specially recognized; now, therefore,
