WHEREAS, Judge Sugarmon is an esteemed member of the Ben F. Jones Chapter of the National Bar Association, the American Bar Association, the Memphis and Shelby County Bar Association, and Alpha Phi Alpha Fraternity, Inc.; and

WHEREAS, he formerly served as a trustee of the Wolf River Conservancy; a board member of the Mid-South Junior Golf Association, a Chapter of First Tee; and Regional Director with the Boy Scouts of America; and

WHEREAS, his many accomplishments aside, Tarik B. Sugarmon is the proud father of three sons, Chris (Britni), Nile, and Malik, and two grandchildren, Dallas and Skylar; and

WHEREAS, throughout his estimable career, Judge Sugarmon has demonstrated the utmost professionalism, ability, and integrity; his commitment to excellence and community service is representative of the Volunteer State, and he should be specially recognized; now, therefore,
