A RESOLUTION to recognize and commend Donna Sue Taylor of Dayton.

WHEREAS, it is fitting that the members of this General Assembly should salute those citizens who, through their extraordinary efforts, have distinguished themselves as community leaders of whom we can all be proud; and

WHEREAS, one such noteworthy person is Donna Sue Taylor, who has distinguished herself as a citizen of the greatest dedication, ability, and integrity; and

WHEREAS, born on November 20, 1941, Ms. Taylor is the daughter of Eloise P. and Donald F. Reed; she attended Dayton City School and is a 1959 graduate of Rhea Central High School, where she was a member of the band for four years and a majorette; and

WHEREAS, Donna Taylor continued her education, first with a two-year stint at Tennessee Wesleyan College, where she was a cheerleader, and then at the University of Tennessee, from which she graduated in 1963 with a degree in home economics with an emphasis in textile and clothing; and

WHEREAS, that same year, on June 9, 1963, she married Tom Taylor and moved to Arlington, Virginia, where he was employed by the United States General Accounting Office; in March 1965, the couple relocated to Dayton when Mr. Taylor accepted a position with Robinson Manufacturing Co., and Ms. Taylor began assisting her mother in the family clothing store, N.D. Reed & Son; and

WHEREAS, once settled in Dayton, the couple became active in the Jaycees and Jaycettes and the First United Methodist Church, each of them being lifelong members; while a Jaycette, Ms. Taylor served all local offices as the State Director, and she currently serves her church on the Altar Guild and is responsible for the set-up of the monthly communion service; and

WHEREAS, she has further served her community as a Girl Scout troop leader and a member of Moccasin Bend Council Board of Directors for more than four decades; for her support and dedication, she was awarded a Life Membership in the Girl Scout Council; and

WHEREAS, Ms. Taylor became active in the Rhea County Republican Party when Winfield Dunn ran for governor and continued her service with Lamar Alexander's "Walk Across Tennessee" gubernatorial campaign; she has served the *Rhea County Republican* as secretary and has been an active member for a number of years; and

WHEREAS, Donna Taylor also followed in the footsteps of her mother and mother-in-law by becoming an active member of the Four Seasons Garden Club; such has been her devotion to that organization that she has received Life Membership with the club and with the Tennessee Federation of Garden Clubs; and

WHEREAS, Ms. Taylor has been blessed with the love and companionship of her children, Kimberly Sue, Allen Reed, and Jeffrey Thomas, as well as eight grandchildren and four great-grandchildren; and

WHEREAS, Donna Taylor epitomizes the spirit and commitment that are characteristic of a true Tennessean, and she should be specially recognized for her many accomplishments and devoted work; now, therefore,
