A RESOLUTION to commend and congratulate Tyler Williams, National HealthCare Corporation Administrator of the Year.

WHEREAS, it is our privilege to recognize those working in the healthcare field whose knowledge, ingenuity, and dedication contribute greatly to the health and well-being of the citizens of this State; and

WHEREAS, one such individual is Tyler Williams, who was recently honored as the National HealthCare Corporation (NHC) Administrator of the Year, a most befitting honor that recognizes his many contributions to health care in East Tennessee; and

WHEREAS, NHC is a senior care company based in Murfreesboro with seventy-five healthcare centers that operates nearly 10,000 beds nationally and provides assisted living, home care, hospice, mental health, pharmacy, insurance, and management services; and

WHEREAS, Tyler Williams holds a Bachelor of Business Administration degree in Health Care Administration from Milligan College; he has worked for NHC since 2006 and is a graduate of NHC's Administrator Training Program; and

WHEREAS, Mr. Williams has served as the administrator at NHC Johnson City since February 2016; during his venerable tenure, he has served patients and partners with integrity and aplomb, winning the respect and admiration of his colleagues; and

WHEREAS, in 2021, under Mr. Williams's leadership, NHC Johnson City was designated an NHC-5 Star Center of Excellence and had an in-house acquired pressure ulcer rate of 0.01 percent, a Consumer View score of 94.22 percent, a Patient Care Component of 96.85 percent, and a hospital readmission rate of 8.3 percent; and

WHEREAS, NHC Johnson City is also designated as a CMS 5-Star Center, indicating that the facility is in the top ten percent of all skilled nursing centers; and

WHEREAS, Mr. Williams's receipt of the NHC Administrator of the Year honor comes after being nominated previously for five consecutive years, a testament to the consistency of his excellence and dedication; and

WHEREAS, throughout his many successes, Tyler Williams has enjoyed the love and support of his wife, Shelli; they are the proud parents of two daughters, soon to be three in August; and


