A RESOLUTION to commend Representative Eddie Mannis for his honorable and astute service to the people of Tennessee as a member of the House of Representatives.

WHEREAS, no stranger to accolades, Representative Mannis is an East Tennessee Business Hall of Fame inductee and a recipient of the FBI Director's Community Leadership Award, the Service to Mankind Award from the Knoxville Sertoma Club, the Community Excellence Award from the U.S. Chamber of Commerce, the Generations of Service Award from the Medal of Honor Society, the Lifetime of Service Award from the Vietnam Veterans of America, and the PBS Be More Award; and
