WHEREAS, in 2006, Judge Poole was elected to serve as the Criminal Court Judge for Hamilton County and was subsequently reelected in 2014 by the citizens of Hamilton County; and

WHEREAS, prior to his judicial service, Judge Don Poole was in private practice from 1972 to 2006 and previously served as an Assistant District Attorney in Hamilton County; he has served in the Judge Advocate Generals Corps of the United States Armed Forces and as a clerk for the Tennessee Supreme Court; and

WHEREAS, no stranger to honors and accolades, Judge Poole has been specially recognized by Court Watchers and named a recipient of the Outstanding Judicial Service Award; and

WHEREAS, a proud Tennessean, Judge Don Poole received his bachelor's degree from the University of Tennessee, Knoxville and his J.D. from the University of Tennessee College of Law; and

WHEREAS, an active part of his community, Judge Poole is a member of the Rotary Club and Brainerd United Methodist Church, where he serves as a Sunday School teacher; and


