WHEREAS, Ms. Ellison's remarkable success as a public servant and civic leader is directly attributable to her reliance on the time-honored values of hard work and common sense and her uncommon ability to work well with people from all walks of life; and

WHEREAS, throughout her many successes, she has enjoyed the love and support of her husband of forty-nine years, Gary Ellison; and

WHEREAS, Rita Ellison is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the Volunteer State, and she should be specially recognized; now, therefore,
