WHEREAS, Dr. Paula Hinson has given back to her profession by serving in a host of leadership positions throughout her illustrious career; since 1983, she has served in MAPS roles and as a member of the Tennessee Pharmacist Association and the Tennessee Society of Health System Pharmacists; and

WHEREAS, ever committed to effecting change that benefits professionals and patients alike, she has also served as president of the UTHSC College of Pharmacy Alumni Board; and

WHEREAS, Dr. Hinson was a member of the Tennessee Board of Pharmacy from 1996 to 2002, in which capacity she fully accepted the challenge to serve Tennessee citizens ahead of her role as a pharmacist advocate; and
