## **HOUSE RESOLUTION NO. 184**

A RESOLUTION to honor Dr. Sarah Eudaley on receiving the 2020 Recent Alumna Award from the University of Tennessee Health Science Center College of Pharmacy.

WHEREAS, the members of the House of Representatives take great pleasure in recognizing a dedicated professional who has excelled through an interdisciplinary approach to pharmacy education, clinical pharmacy, and family medicine; and

WHEREAS, Sarah Eudaley, PharmD, was recently honored by her alma mater, the University of Tennessee Health Science Center (UTHSC) College of Pharmacy with the 2020 Recent Alumna Award, which recognizes "an outstanding graduate within the last ten years whose achievements have been significant to the UT Health Science Center, to the general welfare of his/her community, and to his/her profession"; and

WHEREAS, Dr. Eudaley received a Bachelor of Science degree from East Tennessee State University in 2005 and a PharmD from the UTHSC College of Pharmacy in 2009; after graduation, she completed a pharmacy residency at the University of Tennessee Medical Center, followed by a pharmacotherapy specialty residency with the University of Tennessee College of Pharmacy and University of Tennessee Medical Center; and

WHEREAS, prior to joining the faculty at her alma mater in 2016, she held full-time faculty positions at schools of pharmacy in Alabama and Florida with practice sites in inpatient adult medicine; and

WHEREAS, Dr. Eudaley is currently an assistant professor in the Department of Clinical Pharmacy and Translational Science at the University of Tennessee Health Science Center College of Pharmacy and also holds an adjunct faculty appointment in the Department of Family Medicine at the University of Tennessee Graduate School of Medicine; and

WHEREAS, she practices with the inpatient family medicine service as a clinical pharmacy specialist at the University of Tennessee Medical Center and is also involved in medication therapy optimization initiatives in the outpatient family medicine resident clinic; and

WHEREAS, actively involved in pharmacy resident education, Dr. Eudaley currently serves as the residency preceptor for the twenty-four-month pharmacotherapy residency program and the co-director of the statewide Teaching and Learning Program; and

WHEREAS, her teaching responsibilities within the College of Pharmacy include serving as course director for the pulmonary therapeutics module and the ambulatory care elective; she also teaches in the cardiology and infectious diseases modules and serves as a rotation preceptor for third- and fourth-year students; and

WHEREAS, during her time as a faculty member, Dr. Eudaley has been recognized for her teaching, most recently receiving the 2018 Full-Time Faculty Preceptor of the Year award from the College of Pharmacy; and

WHEREAS, Dr. Eudaley is an active member of the American College of Clinical Pharmacy and is currently serving a two-year term as secretary/treasurer for the Education and Training PRN; and

WHEREAS, a pharmacist and pharmacy educator of uncommon ability, Dr. Sarah Eudaley is richly deserving of our approbation; now, therefore,
