WHEREAS, Dr. Cost served as board president of the Alliance for Patient Medication Safety, a federally registered patient safety organization focused on continuous quality improvement within the pharmacy community; and

WHEREAS, throughout his illustrious career, Dr. Cost has given back to his profession by serving in leadership positions with numerous associations and coalitions; and

WHEREAS, Dr. Cost is the current chair of the American Pharmacists Association's Policy Committee and previously served as a board member of the National Alliance of State Pharmacy Associations and as president of the Tennessee Society of Association Executives; he also served his alma mater as a member of the board of directors for the UTHSC College of Pharmacy Alumni Association; and

WHEREAS, Dr. Cost has had the privilege of delivering more than 100 educational programs, presentations, and lectures covering a variety of different discussion topics to thousands of individuals with diverse backgrounds; and
