WHEREAS, she eventually returned to Chicago and completed her bachelor's degree at Roosevelt University; while working at an accounting firm, Mrs. Sawyer met and subsequently married her husband, Andrew Benjamin Sawyer, Jr.; she is the loving mother of two children, Michael Anthony Hooks, Jr., her pride and joy, and Tamara Ashley Sawyer, her legacy and sidekick; and


