WHEREAS, known as the "go-to fix-it guy" who could repair anything, Dennis Russell was nominated and approved as a Lifetime Member of the Giles County Fire Rescue in 2021; he has been and will always be a core member of the organization; and

WHEREAS, Mr. Russell exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout his years of service, Dennis Russell has demonstrated the utmost professionalism, ability, and integrity, winning the respect and admiration of his fellow firefighters and the residents of Giles County; now, therefore,
