A RESOLUTION to honor the memory of John Thomas Harvey of Oliver Springs.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of John Thomas Harvey; and

WHEREAS, Mr. Harvey was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born on December 30, 1955, John Harvey was the third child of Claude Smith "Sonny" Harvey, Jr., and Maxine Brown Harvey; he graduated from Oliver Springs High School and went to Tennessee Tech University, where he was a member of the Sigma Phi Epsilon fraternity. While taking college courses, Mr. Harvey also obtained certification as an emergency medical technician and worked for both the Putnam County and Anderson County Emergency Medical Services; and

WHEREAS, Mr. Harvey was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, John Harvey enjoyed the loving companionship of his wife of thirty-eight years, Donetta Haynes Harvey, and was the proud father of Rebecca Harvey (Chris) Rowe and Katelyn Harvey; and
