HOUSE BILL NO. 1538

AN ACT to amend Chapter 380 of the Private Acts of 1947; as amended by Chapter 20 of the Private Acts of 1969; Chapter 112 of the Private Acts of 1987; Chapter 96 of the Private Acts of 2002; Chapter 64 of the Private Acts of 2008; Chapter 13 of the Private Acts of 2019; and any other acts amendatory thereto, relative to the highway commissioners of Robertson County.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 380 of the Private Acts of 1947, as amended by Chapter 20 of the Private Acts of 1969, Chapter 112 of the Private Acts of 1987, Chapter 96 of the Private Acts of 2002, Chapter 64 of the Private Acts of 2008, Chapter 13 of the Private Acts of 2019, and any other acts amendatory thereto, is amended by deleting Section 6 and substituting instead the following:

Section 6. That for their services as highway commissioners, they shall receive five hundred twenty-five dollars (\$525) per month, with the chairman to receive the same amount. All of such expenditures shall be defrayed from the highway funds of said county. This section does not increase the compensation of any commissioner during the term for which such commissioner was elected.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of Robertson County. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.
