HOUSE JOINT RESOLUTION NO. 44

A RESOLUTION to honor the Shelby Chapter of the National Society of the Daughters of the American Revolution on the chapter's 125th anniversary.

WHEREAS, we take great pleasure in recognizing those outstanding civic organizations and their members who work with purpose, commitment, and enthusiasm to preserve this State's panoramic history and heritage; and

WHEREAS, one such worthy organization is the Shelby Chapter of the National Society of the Daughters of the American Revolution (DAR), which recently celebrated its 125th anniversary; and

WHEREAS, February 17, 2022, marked 125 years since the founding of the Shelby Chapter of the DAR in Shelbyville; the Shelby Chapter was the eighth chapter founded in Tennessee and was begun by thirteen women born of pioneering ancestors; and

WHEREAS, just as the city of Shelbyville was named in honor of Colonel Isaac Shelby, a courageous American Revolutionary War hero, the founding Shelby Chapter members chose Colonel Isaac as their namesake; and

WHEREAS, the Shelby Chapter's honored members are descended from the patriots who won American Independence during the Revolutionary War; and

WHEREAS, members of the Shelby Chapter of the DAR are very involved in community activities, churches, and civic clubs and work tirelessly to preserve the history and institutions of their county and region, just as their predecessors did; and


