WHEREAS, thoughtful of this world and the next, Mr. Owen is a member of Mount Carmel Baptist Church in Signal Mountain; and


WHEREAS, it is appropriate that we should pause to recognize William Owen as one of the most outstanding young people in our State; now, therefore,
