## HOUSE JOINT RESOLUTION NO. 178

A RESOLUTION to recognize and honor the *Independent Appeal* of McNairy County.

WHEREAS, it is fitting that we should specially recognize those media outlets that are dedicated to the preservation of our great democracy and the perpetuation of truth; and

WHEREAS, one such estimable outlet is the *Independent Appeal*, a McNairy County newspaper that ceased production in December 2022 after 120 years of devoted media service; and

WHEREAS, the oldest existing business in McNairy County, the *Independent Appeal* was family-owned and -operated by the Rail family for forty-three years; and

WHEREAS, from its inception, the *Independent Appeal* operated under the tenets of printing truthful news stories and moving the community in a positive direction; and

WHEREAS, having evolved with the years, the earliest pages of the *Independent Appeal* were pasted together and shot like a photo; as the years passed, computers were introduced in the 1980s and made production significantly easier and more accessible; and

WHEREAS, the *Independent Appeal*, which started without paying subscribers when it was purchased by the Rail family, grew to an all-time high of 7,000 papers in circulation; and

WHEREAS, Janet Rail, the most recent publisher of the *Independent Appeal* and daughter of the previous owner, purchased the publication from her father in 2000 and took over the business permanently in 2009; and

WHEREAS, the Rail family, along with previous owners, made the *Independent Appeal* a vital part of McNairy County's business landscape and economy; and


WHEREAS, for more than twelve decades, the *Independent Appeal* provided superior publication and news services, and it is fitting that this iconic McNairy County business be recognized; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRTEENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we recognize and honor the *Independent Appeal* for 120 years of stellar service, extending our sincere gratitude for its dedication to McNairy County and its citizens.
