HOUSE JOINT RESOLUTION NO. 236

A RESOLUTION to confirm the appointment of David Crowell of Shelbyville to the Tennessee public utility commission.

WHEREAS, Tennessee Code Annotated, Section 65-1-101, creates the Tennessee public utility commission; and

WHEREAS, Tennessee Code Annotated, Section 65-1-101(a), provides that two (2) commissioners of the Tennessee public utility commission shall be appointed by the Speaker of the House of Representatives; and

WHEREAS, Speaker of the House Cameron Sexton has appointed David Crowell of Shelbyville to serve as a member of the Tennessee public utility commission for a term that will expire on June 30, 2026; and

WHEREAS, Mr. Crowell retired from Shelbyville Power, Water and Sewerage System after serving thirty-seven years in various roles, including accountant, office manager, assistant general manager, and general manager, in which position he served for twenty-one years; and

WHEREAS, he is an active member of his community, serving as chairman of the Shelbyville/Bedford County Industrial Development Board and chairman of the Tennessee Walking Horse National Celebration Board; and

WHEREAS, additionally, he is a former board member of the Shelbyville/Bedford County Chamber of Commerce, the Tennessee Municipal Electric Power Association, the Middle Tennessee Industrial Development Association, the Central Service Association, and the Bedford County Joint Economic Development Board; and

WHEREAS, after graduating from Shelbyville Central High School in 1979, Mr. Crowell received a Bachelor of Business Administration from Middle Tennessee State University in 1983; and

WHEREAS, his many professional milestones aside, Mr. Crowell is most grateful for his wife, Tammy; their children, Josh (Brandi) Crowell and Dr. Chelsey (Zack) Gregory; and their three granddaughters, Olivia Crowell, Sarah Cate Gregory, and Lucy Gregory; and

WHEREAS, Tennessee Code Annotated, Section 65-1-101(d), provides that each appointment to the commission shall be confirmed by joint resolution of the General Assembly; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRTEENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we confirm the appointment of David Crowell of Shelbyville to serve as a member of the Tennessee public utility commission for a term to expire on June 30, 2026.
