WHEREAS, Reverend Pierce answered his call to ministry at a young age and began preaching in his teenage years; he has pastored several churches throughout West Tennessee, and he is the current pastor of Wrights Chapel Missionary Baptist Church in Collierville; and

WHEREAS, a graduate of Union University in Jackson, Reverend Pierce earned an Associate of Divinity degree and a Bachelor of Science degree in Organizational Management; additionally, he received honorary degrees from Brewster's Theological School of Religion in Memphis; and

WHEREAS, a leader in his community beyond his duties as a pastor, Reverend Pierce is a renowned guest speaker, evangelist, and lecturer; he is president of the Fayette County Citizens for Progress, a member of NAACP Somerville Branch, and a past member of the Fayette County Board of Education; and

WHEREAS, he was the first Afro-American pastor from Fayette County to serve as "Chaplain of the Day" for the Tennessee House of Representatives and as a legislative advisor to Representative Page Walley; he is also the recipient of several other awards, and he is a member of numerous fraternal organizations; and

WHEREAS, aside from his many professional accomplishments, Reverend Pierce is most grateful for the love and support of his cherished wife, Alfreda D. Herron Pierce; his children, Travis, Rosalyn, Jaylon, and Tony, Jr.; and his grandson, Jayden; and


