A RESOLUTION to recognize Isaac Katz upon his appointment to the United States Naval Academy.

WHEREAS, it is fitting that we should honor those Tennesseans whose proven dedication to excellence is a great point of pride for this State; and

WHEREAS, one such individual is Isaac Katz, who recently received an appointment to the United States Naval Academy, a true honor and an auspicious beginning to his career of service; and

WHEREAS, established in 1845 in Annapolis, Maryland, the Naval Academy is the second oldest of the five U.S. service academies and educates midshipmen for service in the officer corps of the United States Navy and United States Marine Corps; and

WHEREAS, the mission of the Naval Academy is to develop midshipmen morally, mentally, and physically and to imbue them with the highest ideals of duty, honor, and loyalty in order to graduate leaders who are dedicated to a career of naval service and have potential for future development in mind and character to assume the highest responsibilities of command, citizenship, and government; and

WHEREAS, a senior at Central High School, where he is a member of the Bobcats soccer team, Isaac Katz is the first known student from his school to receive an appointment to the Naval Academy; and

WHEREAS, Mr. Katz intends to study nuclear engineering at the Academy; his ultimate hope is to return to Tennessee and work at Oak Ridge National Laboratory; and

WHEREAS, Isaac Katz is an exemplary young gentleman whose work ethic, integrity, and ability will serve him well as he embarks upon this next chapter; and


