WHEREAS, no stranger to public service, Judge Worley follows in the footsteps of her grandfather, former State Representative Raymond Shadden, who believed strongly in service to the community and ably served his fellow citizens in the General Assembly; and

WHEREAS, an active part of her community, Judge Worley is a member of the board of directors for Fair Park Senior Center, a former chairman of the Cumberland County Republican Party, and a former secretary of the Cumberland County Republican Women's Club; and

WHEREAS, her many professional accomplishments aside, Judge Worley is most thankful for the love and support of her husband, Travis; their daughter, Sophia; and her stepson, Ethan; and

WHEREAS, we are confident that Judge Worley will serve with distinction on the bench as a result of her legal acumen and her ongoing commitment to the highest precepts of American jurisprudence; now, therefore,
