WHEREAS, she and her husband, Jackie Davis, are looking forward to spending more time with their first grandchild, Emma Brooke, after Mrs. Davis retires; and

WHEREAS, Angie Davis is wholly committed to the highest ideals of public service and quality education for all, and she should be recognized on this special occasion; now, therefore,
