WHEREAS, hockey fans are not the only people who adore Gnash, and even celebrities have been known to cozy up to this furry feline; once Gnash defeated The Great One, Wayne Gretsky, in a game of hockey, bubble hockey that is; and

WHEREAS, some say that the first catfish hurled onto the ice at Bridgestone was actually Gnash's lunch; as legend has it, Gnash's freezer was broken, and the cat, looking for a place to keep his fish cool, chose the hockey rink, thus inadvertently starting one of the greatest traditions in the National Hockey League; and
