WHEREAS, in 1982, he was elected to the Sevier County Commission at the age of thirty-nine and continued on the commission for forty-one years, serving on various boards and committees such as the water, education, and budget committees; and

WHEREAS, a true public servant, Mr. Hurst has done his utmost to ensure Sevier County's growth and development, especially in the areas of infrastructure and education; and

WHEREAS, a man of refined leisure, he enjoys hunting, fishing, outdoorsmanship, and, above all, time with his family; Mr. Hurst is fond of traveling with his wife, Marie, and going on hunting trips with his grandsons; and

WHEREAS, Mr. Hurst and his wife have two daughters, Amy Hurst (Rodney) Case and Amanda Hurst (Joe) Ayers, and two grandsons, Jackson William Case and Avery Blake Ayers; and

WHEREAS, Mr. Hurst is a beloved leader, husband, and father in Sevier County who has done tremendous good for his fellow citizens; and

WHEREAS, as Warren Hurst enters his ninth decade, he is an active and productive member of the Sevier County community, admired for his wisdom, guidance, and generosity; and


WHEREAS, we wish to grasp this golden opportunity to specially recognize one of Tennessee's most outstanding citizens on this very special occasion; now, therefore,
