A RESOLUTION to honor and congratulate Emiah Burrowes of Tusculum University on being named to the South Atlantic Conference Volleyball All-Tournament Team.

WHEREAS, we are pleased to recognize and commend those successful college athletes who, through their magnificent exploits, bring honor to Tennessee and serve as exceptional ambassadors of this State; and

WHEREAS, one such estimable individual is Emiah Burrowes of Tusculum University, an athlete of extraordinary talent, skill, and dedication, who has proven herself a formidable competitor on the volleyball court; and

WHEREAS, a senior from Wesley Chapel, North Carolina, Emiah Burrowes was named to the South Atlantic Conference Volleyball All-Tournament Team in recognition of her excellence on the court for Tusculum University; and

WHEREAS, Ms. Burrowes played all seven sets for her university's tournament run, during which she totaled thirty-one kills, twenty-six digs, and three total blocks as an outside hitter. She finished fourth in the Tusculum record book in career attempts per set, ninth in kills, and eleventh in the hitting percentage, and she became the first player in program history to win both SAC Freshman in 2019 and Player of the Year in 2021; and

WHEREAS, Ms. Burrowes epitomizes all that is good in today's student athlete, as she has achieved a high level of success in sports while evincing great character both on and off the court; and

WHEREAS, Emiah Burrowes's notable achievement is a source of great pride for her family, her community, and her school, and it is appropriate that we recognize this accomplished athlete; now, therefore,
