A RESOLUTION to honor the memory of Andrew Jackson York of Jamestown.

WHEREAS, Mr. York was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

York Agricultural Institute and attending the Tennessee Law Enforcement Academy, Mr. York served with acumen and alacrity for forty-one years as a Park Ranger at the Sgt. Alvin C.
