A RESOLUTION to recognize and honor Dr. Brian Noland upon being named an Honorary Alumnus of East Tennessee State University.

WHEREAS, one such individual is Dr. Brian Noland, who was recently named an Honorary Alumnus of East Tennessee State University, a most befitting honor that recognizes his contributions to his community and his profession; and
