WHEREAS, Mrs. Lewis most recently served as the treasurer of the Appalachian Highlands Humane Society; she supported feral colonies in her community and ensured that the animals were spayed or neutered, fed, and had a warm place to sleep; and

WHEREAS, a lady of many talents and interests, Mrs. Lewis dedicated her time as a volunteer for Meals on Wheels and the Washington County Republican Party; she often supported efforts to help the homeless through her church; and

WHEREAS, Mrs. Lewis was a cherished member of the Thursday Evening Tea and Bunco Club for Genteel Southern Ladies, and she was an active member of the East Tennessee Republican Club; and

WHEREAS, Mrs. Lewis was committed to her faith, and she was a member of Edgefield United Methodist Church; and

WHEREAS, she was also deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, Mrs. Lewis will be sadly mourned but fondly remembered by her beloved husband, Mark Lewis; a stepdaughter, Amber McKoy; a son-in-law, Brandon; a grandson, Xavier; a brother, Edward (Margaret) Hewitt; and a nephew, Scott Hewitt; and
