WHEREAS, in 1981, Mr. Ramsey started a career in commercial airlines with Sunbelt Airlines, and in 1995, he landed his dream job with FedEx, serving with acumen and alacrity as an airbus captain and earning the respect of his peers and superiors alike for the exemplary quality of his work; he served in the position for twenty years before his retirement in 2015 and subsequently continued to fly corporate aviation; and

WHEREAS, with a fondness for aviation and forty years of flight experience, Mr. Ramsey often took to the air with his friends and influenced them to become professional airline pilots themselves; and

WHEREAS, aside from his many professional accomplishments, Mr. Ramsey was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Mr. Ramsey will be sadly missed but fondly remembered by his beloved wife of nearly forty-three years, Cheryl Ramsey; his sons, Preston (Shelby) and Phillip (Elisabeth); his cherished grandchildren, Macallen, Price, Porter, Walker, and Madelyn; a brother, Mark (Carol) Ramsey; and a host of cousins whom he loved dearly; and
