SENATE JOINT RESOLUTION NO. 266

A RESOLUTION to honor and congratulate the Mid-South Carpenters Regional Council Training Trust Fund on the opening of a new training center.

WHEREAS, it is fitting that we recognize the start of new ventures that will enrich communities and strengthen Tennessee's economic health and well-being; and

WHEREAS, one such estimable endeavor is the new training center for Mid-South Carpenters Regional Council Training Trust Fund, which will train the next generation of apprentices in the construction industry with the most advanced classrooms and equipment; and

WHEREAS, located in La Vergne, the new 25,000-square-foot facility will serve as the most innovative training center for Union Carpenters and Millwrights in the region, providing much-needed workspace and the newest equipment; and

WHEREAS, the new training center will offer a number of classes in carpenter skills, such as metal stud framing, drywall, doors and hardware, flooring, heavy form/concrete, and scaffolding; millwright coursework in compressors and pumps, conveyors, flowserve, gas and steam turbine, machinery alignment, welding, and mechanical print reading; safety training in OSHA 10 and 30, confined space, fall protection, hazard communication, and AED/First Aid; and soft-skills training in leadership, jobsite communication, and human performance; and

WHEREAS, the new training center will also feature two mechatronics/robot stations that will be used to train for automotive plant projects; a conveyor training area that will be used to train on-floor conveyor and power and free monorail systems; and a number of classrooms, conference rooms, and computer labs; and

WHEREAS, by its increased investment in Tennessee because of the region's booming economy and construction services, the Mid-South Carpenters Regional Council Training Trust Fund will undoubtedly fulfill its vision to prepare a local workforce of construction industry professionals with the skills needed to improve the quality of life for both themselves and their communities; and

WHEREAS, the lifeblood of this State's economy and the foundation of our communities are those endeavors that truly seek to serve their neighbors in conscientious and meaningful ways; and

WHEREAS, it is most fitting that we recognize the Mid-South Carpenters Regional Council Training Trust Fund on this most auspicious occasion; now, therefore,
