A RESOLUTION to recognize Elijah Taylor upon attaining the rank of Eagle Scout.

WHEREAS, a senior at Smyrna High School, where he is a member of the varsity bowling team, he plans to attend Middle Tennessee State University and later teach high school history at his alma mater; and

WHEREAS, it is appropriate that we should pause to recognize Elijah Taylor as one of the most outstanding young people in our State; now, therefore,
