WHEREAS, her house was a locus of loving kindness for her family and friends, and many gatherings of great memory were held under her roof; and

WHEREAS, she was also deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, Mrs. Cole will be sadly mourned but fondly remembered by her children Joe (Lora) Cole, Margaret Losey, Anita (Joe) Moore, and Jeff Cole; her sixteen grandchildren; twenty-nine great-grandchildren; twenty-eight great-grandchildren, and a host of extended family and dear friends; and

WHEREAS, in addition to her parents, she was preceded in death by her husband, Glenn Cole; her sons Ross, Denny, and Kenny Cole; her brothers, Robert, Jr., Buford, and James Howell; and her son-in-law, Frank Losey; and
