A RESOLUTION to recognize Frank Lannom for his honorable service to the State of Tennessee.

WHEREAS, one such noteworthy individual is attorney Frank Lannom of Wilson County, the 2021-2022 president of the Tennessee Association of Criminal Defense Lawyers (TACDL); and

WHEREAS, he is also known for embarking upon yearly 1,300-mile, nonstop trips from South Dakota to speak at TACDL's annual DUI seminar accompanied by his bird dog, Mac; and

WHEREAS, a lifelong resident of and business owner in Wilson County, Mr. Lannom maintains an active family farm and raises beef cattle and horses when not practicing law; and

WHEREAS, committed to serving the needs of his community, Frank Lannom provides thoughtful contributions to youth sports and band activities and evinces exceptional volunteerism and professionalism in all his endeavors; and

WHEREAS, Mr. Lannom prioritizes his faith and family and is an active member of his church as well as a member of The Tribe of Judah Motorcycle Ministries, which carries the message of the cross to the "outlaw" motorcycling world throughout the United States; and

WHEREAS, among the many accomplishments of his legal career, Frank Lannom is most proud of his tireless defense of citizens accused of crimes and ensuring their protection from overreaching government intrusion upon their constitutional rights; and
