A RESOLUTION to recognize Marie Moore on the occasion of her retirement.

WHEREAS, upon retiring, Ms. Moore looks forward to spending more time with her granddaughters, Marcella and Norah; her daughters, Sarah, Laura, and Caitlin; her son-in-law, Ermal; and her husband, Richard; and

WHEREAS, Marie Moore exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout her estimable career, Marie Moore has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of her colleagues and community alike; now, therefore,
