CHAPTER 0465-01-04 PUBLIC RECORDS

Withdrawal of the following amendments:

0465-01-04-.03 LEGAL BASIS.

To be amended by removing “as amended by 2018 Public Chapter 712” from the Authority section.

0465-01-04-.10 INSPECTION OF RECORDS.

To be amended by adding a new paragraph (4) and an additional statute to the Authority section, which shall read:

- (4) During the inspection, the requestor shall have the right to make copies and take photographs or photostats of complete or partial records. However, DIDD will not certify the accuracy of copies, photographs, or photostats made with the requestor’s personal equipment, such as a printer, a cell phone, or a copy machine.
