Summary of relief requested:

Petitioner requests the Board to construe T.C.A. §67-5-901, §67-5-903, and rules of the Board, including Rule 0600-5-.01 (6) so as to avoid the company having to include in depreciable cost certain 'shutdown costs' associated with periodic maintenance overhaul of equipment used in manufacturing acrylic.

4. Summary of statute or regulation at issue:

T.C.A. §67-5-901 through §67-5-903 provide for taxpayer self-reporting of business tangible personal property and provide for standard valuation at depreciable cost in the absence of better evidence of fair market value. SBOE Rule 0600-5-.06 provides that taxable standard value for depreciable property is presumed to be the greater of residual value or original cost to the taxpayer less straight line depreciation. SBOE Rule 0600-5-.01 (6) defines "original cost" as "gross capitalized cost before depreciation."

5. Hearing

The Board will convene a contested case in this matter before its hearing officer or administrative judge in Memphis on October 4, 2010. Participation in these proceedings will be limited to persons admitted as parties, and any interested person desiring to participate must request to intervene pursuant to Tenn. Code Ann. §4-5-310. The hearing will be conducted in the manner prescribed by the Uniform Administrative Procedures Act pursuant to further notice which will be provided in writing to persons requesting it.
