1320-8-2-.01 CARD AND CERTIFICATE. Operators of freight motor vehicles registering under the International Registration Plan shall be issued a Cab Card and a Certificate of Registration for each vehicle so proportionally registered. The Cab Card is issued at no additional cost and shall remain valid as long as the registration status of the vehicle remains unchanged, unless the card is lost, stolen, destroyed or revoked by the Department.

1320-8-2-.02 PLACEMENT OF CARD. For a vehicle proportionally registered, it is required that the original of the Cab Card be in the cab of the vehicle during its operation.

1320-8-2-.03 REPLACEMENT CARDS. In the event a Cab Card is lost, stolen or destroyed, the registrant must make application to the Department on Form MV-a-313, and remit a fee of \$2.00 as indicated on the form for the replacement card.
