1320-8-7-.01 APPLICATION. In the event any license plate(s) shall be lost, stolen, destroyed, mutilated or so damaged as to be illegible, the person who is the holder of the valid and outstanding Tennessee registration identifying such plate(s) shall make immediate application to the County Court Clerk for replacement thereof.

1320-8-7-.02 PROCEDURE. Application for the replacement shall be made under oath on a form to be provided by the Department, and the applicant shall deliver the certificate of registration to the Clerk in order to ensure replacement on the proper vehicle. All damaged, illegible or retained plates shall be surrendered to the Clerk at the time of application for replacement.

1320-8-7-.03 SUBSTITUTES AND DUPLICATES. The licensee may in his discretion apply for a substitute plate(s) bearing legend appropriate to the registration classification, or for duplicate plate(s) displaying legend identical to the missing or illegible plate(s).

1320-8-7-.04 TEMPORARY LICENSE. If the application is for duplication of the plate(s), the County Court Clerk may issue a temporary license for display in the window of the vehicle pending manufacture and issuance of the new plate(s). The interim license shall not be issued for a period to exceed twenty-eight (28) days.

1320-8-7-.05 DUPLICATION FEE. The fee for duplicating any plate or set of plates issued under a certificate of registration evidencing payment of the holder's motor vehicle privilege tax shall be in the amount so provided for replacing plates in T.C.A. §55-4-105, as amended, and for any substitute plate(s) to be issued from stock the sum of one dollar (\$1.00).

1320-8-7-.06 APPLICATION FEE. In taking an application for duplicate plates and issuing the interim license, or for taking an application for substitute plates and issuing a certificate under a new number, including acknowledging a signature in either instance, a county court clerk shall be entitled to a fee of one dollar (\$1.00).
