Amendment

1660-01-15-.02, Importation Of Wildlife Carcasses, Parts, And Products is hereby amended by deleting the current language in its entirety and substituting the following language so that, as amended, the rule shall read as follows:

- (1) No person may import, transport, or possess in Tennessee a cervid carcass or carcass part from anywhere outside the state except as provided herein:
  - (a) Meat that has bones removed.
  - (b) Antlers, antlers attached to cleaned skull plates, or cleaned skulls (where no meat or tissues are attached to the skull.)
  - (c) Cleaned teeth.
  - (d) Finished taxidermy and antler products.
  - (e) Hides and tanned products.

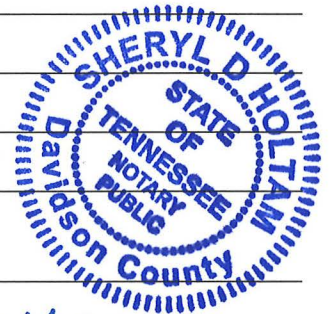
