Statement of Necessity:

Pursuant to Tenn. Code Ann. §4-5-208(a)(1), the Agency submits that an immediate danger to public safety has arisen because of storm damage to Fort Loudoun Marina on Fort Loudoun Lake in Lenoir City, Tennessee. The damage from wind and snow events in January 2024 has caused the marina's boat dock roof to collapse and has compromised infrastructure as well as private property which includes the business property of the marina owners and members of the public utilizing the marina's boat slips.

The section of the impoundment, due to location and frequent vessel traffic, has proven dangerous for the team of workers, divers, and salvage operators to safely remove debris with the rocking motion of these very dangerous collapsed structures because of large wakes. There have been several near incidents with workers present and several incidents of tools and gear failing into the water because of the wakes created by vessels. Additionally, the wakes have also caused additional oil and fuel to be spilled in the water as many of the boats are depressed heavily in the water due to the roof collapse. The marina recognized the dangers at play and requests assistance from the agency. Given the safety concerns for the workers, divers, and salvage operators and the environmental impacts with fuel and oil discharge, the Agency submits that measures to reduce the wakes around these partially sunken docks and vessels is necessary.

Because of the time needed for cleanup from the storm damage, a temporary "Slow-No Wake" speed zone is being sought to allow the marina a 180-day window to safely conduct clean up activity. It is not anticipated a permanent rule will be sought to continue this emergency rule created zone.

The agency believes this issue is an immediate danger to public safety and is such that any other method of rulemaking would not adequately and timely address the urgent issue.

The emergency rule contemplated with this filing would establish a 1,500 foot "Slow-No Wake" speed around Fort Loudoun Marina on Fort Loudoun Lake in Lenoir City near Tennessee River Mile Marker 602. There are currently no restrictions relative to wake speed on that section of the lake.

(B) A citation to and brief description of any federal law or regulation or any state law or regulation mandating promulgation of such rule or establishing guidelines relevant thereto:

The only federal regulations that would apply are Coast Guard regulations which are contemplated in the Agency's process and considerations. There are no mandates in those requirements relative to this specific matter.

(C) Identification of persons, organizations, corporations or governmental entities most directly affected by this rule, and whether those persons, organizations, corporations or governmental entities urge adoption or rejection of this rule;

Owners of storm-damaged assets, Fort Loudoun Marina and its patrons, workers and divers involved in the cleanup, Lenoir City, Loudoun County, and users of the relevant section of waterway.

It is presumed that the majority of stakeholders would be in favor of safe, quick, and efficient damage repair and cleanup that thus urge adoption. Users of the relevant section of waterway could urge rejection to slowing down at the determent to the other stakeholders and those persons charged with cleanup.

There are no Attorney General Opinions on point to this specific matter.

1660-02-07-.14 FORT LOUDOUN LAKE.

- (1) All vessels being operated within the mouth of Little Turkey Creek from the Northshore Drive Bridge to a point approximately 600' within the cove delineated by a line of informational buoys or signs shall operate at a "Slow-No Wake" speed.
- (2) All vessels are prohibited from two Fort Loudoun Dam Reservation swimming beaches (T.R.M. 602.5R) and Yarberry Peninsula swimming beach (T.R.M. 604.6L) as delineated by a line of "No Boating" buoys.
- (3) Vessels being operated on Fort Loudoun Lake at Fort Loudoun Dam Reservation Boat Ramp (T.R.M. 602.5R) as delineated by a line of informational buoys or signs shall operate at a "Slow-No Wake" speed.
- (4) Vessels being operated on Fort Loudoun Lake at T.V.A.'s Poland Creek Recreation Area public ramp (T.R.M. 620.3) as delineated by a line of informational buoys or signs shall operate at a "Slow-No Wake" speed.
- (5) All vessels are prohibited in the Knox County Concord park Swimming Beach Area at Fort Loudoun Reservoir (Tennessee River Mile 616.3R) as delineated by a line of "No Boating" buoys.
- (6) All vessels being operated on Fort Loudoun Reservoir in the area adjacent to the Cowan Park Boat Ramp (Tennessee River Mile 621.5R) as delineated by a line of information buoys shall operate at a "Slow-No Wake" speed.
- (7) All vessels are prohibited from operating within the designated zone near the City of Knoxville water intake. The area is in the vicinity of Tennessee River Mile 649.4.
- (8) Vessels operating on the Little River arm of Fort Loudoun Reservoir near the Hwy 129 bridge and the Norfolk Southern railroad bridge as delineated by lines of informational buoys, shall be operated as follows:
 - (a) Motorboats shall operate at a "Slow-No Wake" speed.
 - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
- (9) All vessels being operated within 1,500 feet of Fort Loudoun Marina, near Tennessee River Mile 602, as delineated by a line of informational buoys, shall be operated at a "Slow-No Wake" speed.
