Repeal of the domestic kitchen license will remove requirements for license fees and routine inspections. Pursuant to Public Ch. 0150, domestic kitchen firms will be allowed to sell products only through direct, retail sales with end consumers or by other means only upon receipt of a Food Manufacturer license.
