### Chapter 0680-01 Licensing

#### Amendments

Rule 0680-01-.16 Appendix A of Rule 0680-01-.12 (Classifications System) is amended by deleting section 1. Limited Residential (r) under Paragraph A. Residential and by substituting the following language so that as amended the new section shall read as follows:

Rule 0680-01-.16 Appendix A of Rule 0680-01-.12 (Classifications System)

1. Limited Residential (r)-A limited residential contractor is authorized to bid on and contract for the construction, remodel, repair, or improvement of a single family dwelling the total cost of which does not exceed one hundred twenty five thousand dollars (\$125,000.00).

Rule 0680-01-.27 Misconduct is amended by deleting paragraph (3) and by substituting the following language so that as amended the new paragraph shall read as follows:

(3) Pulling a building, electrical, plumbing, or like permit for a job in which an unlicensed contractor is the general contractor or to consent or allow for a license number to be utilized by an unlicensed contractor in the furtherance of unlicensed contracting.

## Chapter 0680-01 Licensing

#### **New Rules**

#### Rule 0680-01-.29 Limited Residential License

- (1) The Limited Residential License allows for the construction, remodel, repair, or improvement of single family dwellings in which the total cost does not exceed one hundred twenty five thousand dollars (\$125,000.00).
- (2) The ten percent (10%) tolerance for monetary limitations as stated in Tenn. Comp. R. & Regs. § 0680-01-.13 is not applicable to the Limited Residential License.
- (3) The financial statements for Limited Residential License must reflect a positive net worth and positive working capital.
- (4) The Limited Residential License applicant shall provide proof of any relevant experience in order to qualify for licensure.
- (5) The applicant must participate in a restricted residential license three day course as approved by the Board. The course may be taken at any location approved by the Board. These courses are found on the Board website.
