General Rules and Regulations Governing the Practice of Acupuncturists

Amendments

Rule 0880-12.05 ADS Certification Process is amended by deleting subparagraph (1)(f) in its entirety and re-lettering the remaining subparagraphs and is further amended by adding new paragraph (3) which shall read:

- (3) Prior to the commencement of practice as an ADS, an ADS certificate holder must provide the following documentation to the Committee's Administrative Office:
 - (a) Satisfactory written acknowledgement that the practice of auricular detoxification treatment will be in a hospital, clinic, or treatment facility which provides comprehensive alcohol and substance abuse or chemical dependency services including counseling, and
 - (b) Certification from the supervising licensed acupuncturist or medical director (a physician licensed under Chapter 6 or 9 of Title 63 of the Tennessee Code Annotated) of the institution, facility, or entity attesting to employment and acceptance of supervisory responsibility.

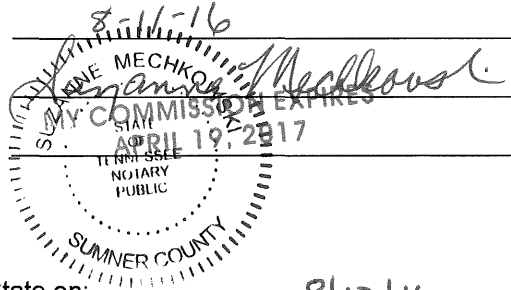
