- (3) First-time applicants for the native Tennessean annual license must submit their application to the Agency's revenue office. Native Tennessean annual license will be identical to annual resident licenses sold by the Agency, but will be properly designated "Native Tennessean."

1660-01-28-.11 is amended by deleting subsection (5).
