##### Explanation of changes:

T.C.A. § 47-18-1612(a) authorizes the secretary of state to promulgate rules to effectuate the purposes of the act.

The Procedures for Operating Charitable Gaming Events, Sections 1360-03-05-.03(2) and 1360-03-05-.04(2) are amended by deleting the requirement of the inclusion of a notarized affirmation with the initial and renewal applications.
